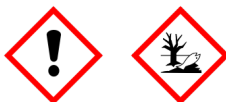

### General notes:






